It has 20 holding companies and 4 share-holding companies, and has established 5 domestic processing and manufacturing bases and 1 overseas clothing production base. , With a garment design proofing center and a national laboratory,

The annual import and export volume of 2020 is nearly 800 million US dollars, and the revenue is 5.8 billion yuan.

The annual export scale of the company's casing exceeds 70 million US dollars, ranking first in the country for more than ten consecutive years, and was evaluated as part-time vice chairman unit by China Chamber of Commerce for Import and Export of Foodstuffs, Native Produce and Animal by-products. It was a part-time vice chairman unit and a director

unit of the casing branch. In 2017, Tongxiang Kaixing Animal by-products Co., Ltd., an animal by-products processing base constructed in accordance with HACCP standards, was officially put into operation; In 2018, as a representative of the national animal product industry, the base successfully passed the EU FVO animal by-products certification with excellent results; in 2019, the base passed the US USDA on-site inspection and obtained the access certification of South Korea, Canada, Brazil and other countries; in 2020, the company participated in the revision of the "Natural Casing" standard of the National Slaughtering and Processing Standardization Technical Committee, and further improved the product definition, classified product name, technical requirements, hygiene and safety, storage and transportation in the original standard.

(3) Technology leads core competitiveness and provides customers with a full range of services. The company focuses on garments as competitive products, and strives to create both ends of the smile curve, relying on the company's testing platform and design proofing center to provide customers with better professional services. In an office area of less than 400 square meters, it has created an amazing performance of 150,000 US dollars per square meter per year and 1.2 million US dollars per capita. At present, Huixiang Inspection is equipped with a series of advanced equipment of famous international brands such as gas mass inductively spectrometry (GC-MS),coupled plasma emission spectroscopy (ICP-OES), high performance liquid chromatography (HPLC),

universal powerful machine, etc. CNAS, CMA and other national certifications provide strong support for ensuring the quality of testing and improving testing efficiency. Che Jun, then secretary of the Zhejiang Provincial Party Committee, highly affirmed the role of the company's testing center and proofing center: "What is the core competitiveness? This is also the core competitiveness."

As well as our province' s medical team that supports Hubei, the remaining part has been donated to the frontline of the epidemic in Hangzhou. In addition, the company also donated 460,000 yuan to Hangzhou Charity Federation, Hangzhou Xiacheng District Public Security Bureau, Hangzhou Shangcheng District Public Security Bureau, Tianshui Street and other units, reducing or exempting small and medium-sized tenants' rents by 380,000 yuan.
